### **AWARD CATEGORIES**

#### **HR Innovation**

For following industry segments: Emerging | Evolving | Matured

Applicants will be divided into industry segments basis: Revenue, Employee Headcount & No. of worksites

### **Future of Work (FOW):**

This may include innovative talent management practices: gig work, flexible workplaces, hybrid work models, unconventional practices, interventions for productivity enhancement and efficiency, etc.

### Technology a Workplace (TaW)

This may include advancements in HR software, virtual collaboration tools, cloud-based systems, Al-driven platforms, digital learning platforms, employee engagement apps, etc.

### NOTE

- All the applications will be primarily considered and evaluated for the 1st category by default for all industry segments
- Remaining applicants will be evaluated for Category FOW & T@W, basis the option selected while filing the application

### **ELIGIBILITY CRITERIA**

- Applicant company should be registered as a legal entity in India, under Section 2 (20) of the Indian Companies Act 2013
- MNCs can also apply provided they have its facilities, plants, and other assets located anywhere in India
- Certificate of incorporation is mandatory for all
- Initiatives / projects that have been implemented during the last 4 years i.e. Jan 2022 to March 2025 will be eligible for nomination
- A fact/evidence approach will be followed to carry out an assessment hence applicants must include supporting/ documentary proofs wherever needed. Assessors/Jury may ask for additional documents and they shall be shared on an immediate basis, failing which the entry may be disqualified
- The Award Management holds the right to disqualify any application which does not meet the eligibility criteria
- If at any time, any information provided by the nominating organization is found to be incorrect in any manner, the nominating organization will be disqualified from the Awards process

### **ASSESSMENT PROCESS**

### STAGE 1 Registration

- Registration
- Orientation of all registered applicants
- Submit application with registration fee

## STAGE 2 Preliminary Screening

- Receiving application of intent
- Preliminary Screening of the applications
- Closure of gaps if any within the specified timeline

### STAGE 3 Evaluation

- Independent review of every application by 2-3 assessors
- Collective evaluation of results by team of assessors for each category
- Shortlisting of applications (category wise) for Jury level review
- Shortlisting of finalists (category wise - 5 - 6 applications) for Presentation to Jury

### STAGE 4

#### **The Winners**

- Final presentation by shortlisted finalists to jury
- Selection of Winners and Runner-ups
- Announcement of award winners during the FICCI Innovation Summit 2025
